

 5. Electronic bids must be submitted to the office **Mahakali Municipality, Office of Municipal Executive** through PPMO website www.bolpatra.gov.np/egp on or before **12:00 hours** on **2077/02/15**. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hours on 2077/02/15** at the office of **Mahakali Municipality, Office of Municipal Executive**. Bids must be valid for a period of **120** after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid.
